## **ORDINANCE NO. 06-695**

AN ORDINANCE OF THE CITY OF FRIEND, NEBRASKA, CREATING THE COMMUNITY REDEVELOPMENT AUTHORITY OF THE CITY OF FRIEND, PROVIDING THAT THE MAYOR OF THE CITY OF FRIEND, NEBRASKA IS AUTHORIZED AND DIRECTED TO IMPLEMENT THE ORDINANCE, AND ORDERING THE PUBLICATION OF THE ORDINANCE IN PAMPHLET FORM.

**BE IT ORDAINED** by the City Council of the City of Friend, Nebraska.

- The City hereby creates the "Community Redevelopment Authority of the City of Friend, Nebraska," with all rights and obligations provided for Community Redevelopment Authorities in the Nebraska Community Redevelopment Law, Neb. Rev. Stat. §18-2101 et. seq. (the "Act"). The Authority shall consist of five persons, all residents of Friend, Nebraska who shall be appointed by the Mayor with the approval of the governing body of the City.
- The Authority hereby created shall function under the direction of its chair and its authorized members and shall exercise the powers herein described or referred to and as determined by resolution or ordinance duly adopted from time to time by the Authority.
- The Mayor of the City of Friend, Nebraska, is hereby authorized and directed to implement this Ordinance.
- The Authority shall exercise all rights and powers granted to Community Development Agencies pursuant to the Act.
- This Ordinance shall be published in pamphlet form and shall take effect and be in full force and effect from and after its passage, approval and publication as provided by law.
- All provisions of any prior ordinance of the City of Friend in conflict herewith are hereby repealed.
