

ORDINANCE NO. 03-654

AN ORDINANCE PROVIDING FOR THE CLOSING AND VACATING OF FLOYD STREET FROM SECOND STREET TO THIRD STREET, THE SAME BEING A REGULARLY ESTABLISHED AND PLATTED STREET WITHIN THE CITY OF FRIEND; TO PROVIDE FOR PUBLICATION OF THIS ORDINANCE IN PAMPHLET FORM; TO PROVIDE FOR A TIME WHEN THIS ORDINANCE SHALL TAKE EFFECT.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF FRIEND, NEBRASKA:

Section 1. Street Vacated. The following street or portions of streets, more particularly described as follows:

Floyd Street from Second Street to Third Street;

as originally platted, is hereby vacated and closed in accordance with the laws of the State of Nebraska, in connection with the vacation and closing of streets and the City Clerk is hereby authorized, empowered, and directed to certify the same to the Register of Deeds of Saline County, Nebraska and to designate upon the official map of the City of Friend the closing and vacating thereof.

Section 2. Public Interest. It is deemed advantageous and in the public interest, safety, welfare, and convenience to vacate and close said street or portions thereof, and that upon vacation and closing, said street shall revert to the owner or owners of lots or lands abutting the same in proportion to the respective ownerships of such lots or grounds.

Section 3. Reservation of Easements. The City of Friend retains the right to maintain, operate, repair, and replace by itself or by any licensee or agent any poles, wires, pipes, conduits, sewer mains, water mains, or any other facility or equipment for the maintenance or operation of any utility now located in said street or portions thereof vacated and closed by this Ordinance.

Section 4. Pamphlet Form; Publication; When Operative. This Ordinance shall be published in pamphlet form and shall be in full force and effect from and after its passage, approval and publication as provided by law and City Ordinance.
