

ORDINANCE NO. 462

AN ORDINANCE OF THE CITY OF FRIEND AMENDING SECTION 11-104, "ELECTRIC SERVICE RATES" OF ORDINANCE NO. 416 OF THE CITY OF FRIEND TO PROVIDE FOR INCREASED ELECTRIC SERVICE RATES FOR THE VARIOUS CLASSES OF SERVICE; ESTABLISHING THE VARIOUS CLASSES OF ELECTRICAL SERVICES; PROVIDING FOR THE REPEAL OF CONFLICTING ORDINANCES, INCLUDING ORDINANCE NUMBERS 400, 402, 430, 435, 440 AND 447 AND PROVIDING FOR THE TIME WHEN THIS ORDINANCE SHALL TAKE EFFECT.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF FRIEND, SALINE COUNTY, NEBRASKA, AS FOLLOWS:

1. Section 11-104. "Electric Service Rates" of Ordinance Nos. 400 and 402 of the City of Friend is amended to read as follows:

"Section 11-104. "Electric Service Rates". The rate of charge for electric service rendered by the City of Friend shall be based on monthly consumption by each consumer and person receiving electric service from and through the distribution system of the City of Friend. The schedule of rates hereby established is as follows:

A. Residential Rate. Applicable to electric energy supplied for private dwellings, for lighting, refrigeration, electrical appliances of all kinds, motors of one horse power, rated capacity or less and certain ranges and heaters not herein-after specifically enumerated under any other residential rate:

Minimum Bill - \$2.00	<u>Winter</u>	<u>Summer</u>
First 150 KWH used per month at	10.06¢	10.06¢
Next 500 KWH used per month at	5.60¢	5.60¢
All over 650 KWH used per month at	4.03¢	4.81¢
Minimum per month per service connection - \$2.00		

B. Residential Rate with 3 KW of permanent connected house heat. The special residential rate is established for residences with 3 KW of permanent connected house heat for the following eight months of the year: October, November, December, January, February, March, April and May as follows:

Minimum Bill - \$2.00	<u>Winter</u>	<u>Summer</u>
First 150 KWH used per month at	10.06¢	10.06¢
Next 500 KWH used per month at	5.60¢	5.60¢
Over 650 KWH used per month at	2.80¢	3.67¢
Minimum per month per service connection - \$2.00		

C. Residential Rate with Electric Water Heaters:

Minimum Bill - \$2.00	<u>Winter</u>	<u>Summer</u>
First 150 KWH used per month at	10.06¢	10.06¢
Next 500 KWH used per month at	4.50¢	4.50¢
All over 650 KWH used per month at	4.02¢	4.81¢
Minimum per month per service connection - \$2.00		

D. General Terms and Conditions Applicable Specifically to Space Heating Service:

All space heaters larger than 1,650 watts shall be designed to operate at 240 volts.

E. No Individual Thermostat or other Switching Device shall have a connected load in excess of 10 Kilowatts unless such installation is specifically approved by the City Electrician or Light Commissioner in writing after personal examination of the conditions in effect on consumers premises.

F. In the case of permanently installed all electric equipment, which is also used for both heating and cooling (heat pump), electrical service will be provided for such equipment under the applicable space heating schedule of rates.

G. The City of Friend cannot and does not assume the responsibility for the installation or operation of the customer's space heating equipment nor can the City assume any responsibility with respect to the customer's premises such as the insulation of the area to be heated, etc. The City will, however, offer such advisory assistance and recommendations as may be desired by the consumer in order to provide the applicant with information for the most economical trouble free installation.

H. Terms and Conditions Applicable to Water Heating Service:

The total of the heating elements of the electric water heater that may be operated at any one time shall not be in excess of 4,500 watts and in no event more than 115 watts per gallon of tank capacity.

I. Commercial Rate of General Service: This is applicable to any customer for lighting, heating, and power purposes where all services are taken through a single meter at one location. The rating of the individual single phase motor served under this schedule shall not exceed five (5) horse power, except by special permission from the City Electrician and Light Commissioner.

The Character of the Service to be provided is as follows:

A.C. 60 cycle 120-240 volt single phase 3 wire 240 volt, 3 phase 3 wire or 240 volt 4 wire service is available by City Facilities. Secondary voltage other than listed above shall be provided by special permission granted by the City Electrician and Light Commissioner as in their judgment after appropriate investigation, they should determine to be necessary.

The commercial power rate for general service shall be:

Minimum Charge - \$2.00

	Winter	Summer
For first 500 KWH used per month at	<u>10.96¢</u>	<u>10.96¢</u>
For next 2,500 KWH used per month at	6.49¢	6.71¢
And for all over 3,000 KWH used per month at	5.14¢	5.37¢

\*When the Customer's demand exceeds 100 KW for three consecutive months, the 2,500 KWH block shall be adjusted to:

Next 165 KWH per KW 6.49¢  
All Additional use 5.14¢

\*\*When the Customer's demand exceeds 100 KW for three consecutive months, the 2,500 KWH block shall be adjusted to:

Next 165 KWH per KW 6.71¢  
All Additional use 5.37¢

This power rate shall be applicable to any customer for use of 3 phase power for motors or combination of motors of 7½ horsepower and above served from a single meter and a single location.

J. Residential Rate for all electric house heat and water heater:

The rates for a residence with all electric house heat and water heater will be as follows:

First 150 KWH used per month at	10.06¢	10.06¢
Next 500 KWH used per month at	4.50¢	4.50¢
All over 650 KWH used per month at	3.10¢	3.67¢
Minimum per month per service connection -	\$2.00	

K. Irrigation:

\$19.65 per Horsepower connected per year, payable with the first billing after May 1st of each year.

\$5.37 per KWH for all energy used

Off Peak Irrigation:

\$9.82 per Horsepower connected per year payable with the first billing after May 1st of each year.

\$4.70 per KWH for all energy used

L. Space Heating with 2 Meters:

Minimum Bill: The Customer Charge Winter

Customer Charge \$2.00  
Plus: First 100 KWH 4.81¢  
All Over 100 KWH 2.91¢

The Customer Charge Summer


Customer Charge \$2.00  
Plus: First 100 KWH 5.37¢  
All Over 100 KWH 3.80¢

M. Winter rates are defined as the rates for the months of October, November, December, January, February, March, April and May, and Summer rates are defined as the rates for the months of June, July, August and September.


Section 2. All of the rate provisions of all prior Ordinances are hereby repealed.
