Debbie- As mentioned in my phone call this morning I've had several conversations with Mike's bank. I was told to contact his loan officer directly, which I did yesterday and left a voice mail with him. He hasn't returned my call.

I think what is happening is that the city has a first lien on some real estate by virtue of a loan from the revolving fund. Mike's bank is doing a financing package for him and probably wants us to either, a) subordinate our lien to the one from the bank, or, b) pay us off.

The decision on what to do is up to the council. I wouldn't advise the council to subordinate the lien unless we have a good history of repayment with Mike, AND there is plenty of equity in the property to cover our outstanding loan amount. Unless these factors are clearly met to the council's satisfaction, (particularly the second) I'd suggest to the council that they not agree to subordinate our lien, and just seek a payoff.

For some reason I was listed as the trustee of the deed of trust, so if we release our lien upon getting a full payoff, I would have to sign the release document. I won't be able to do so until I return from vacation on June 18.

Also, in reviewing the agenda describing the ordinance regarding the various street improvement districts, you'll recall that the district that was formed for the Page and 5th st. project was already titled as #2012-1, so we should change the numbers of the districts in this new ordinance and in the corresponding resolution to begin with #2012-2 and so on.

Please pass this along to the council in the event I'm not at tonights meeting. Thanks.
