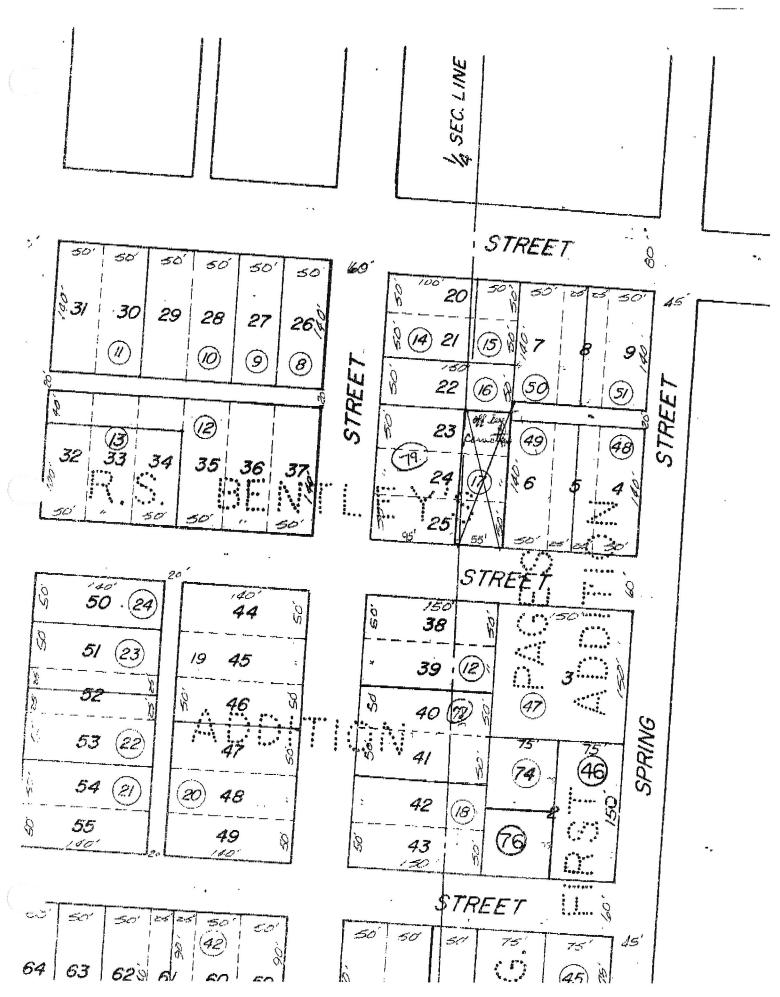

Debbie- Visited with Roger last night. As I understand it Stan is interested in buying a city owned lot. I told Roger that we need to pay attention to the state law and city ordinance (8-107) relating to the sale of municipal real estate. If we are going to sell it, and we believe that the property is valued at less than \$5000, we can pass a resolution indicating that we would sell the real estate, and post a notice in at least 3 places indicating the property for sale, and indicating the terms and conditions of the sale (these would have to be determined by the council). The notices have to be posted at least 7 days before the sale takes place. We would pass an ordinance after the sale is completed approving the sale.

If we think that the property is worth over \$5000, we would have to pass a resolution directing the sale at public auction or by sealed bids. We then have to publish a notice of sale in the paper for 3 consecutive weeks before we can hold the sale. The public can exercise a right of remonstrance protesting the sale within 30 days after the 3rd publication and if they get enough signatures of registered voters on a petition, the sale is off. I think they need at least 30%. After the 30 day period has passed, and assuming we don't have a protest, we can sell the real estate. If we receive an agreeable bid, we then have to pass an ordinance approving the sale.

As you can see it gets much messier if we are dealing with more valuable property, and more time consuming. We can put this on the agenda for discussion on May 2, unless Roger puts it on for the earlier meeting.
