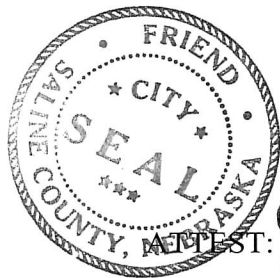
BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FRIEND,
NEBRASKA:



RESOLUTION NO. 05-05

A Resolution of the City of Friend, Nebraska pertaining to the sale of certain real estate:

WHEREAS the City of Friend, Nebraska is the owner of real estate generally located at 118 Main Street in Friend, Nebraska and legally described as Lot 160 of the Original Town; and,

WHEREAS, the City Council has previously advertised this real estate for sale with the requirement that the successful bidder furnish a plan for the demolition of the existing structure located upon this real estate, and,

WHEREAS, other members of the public have indicated an interest in attempting to renovate the real estate and the improvements located thereupon and,

WHEREAS, the bids received from the initial advertising of the sale of this real estate were not adequate, and were subsequently denied by the City Council, and,


WHEREAS, the City Council intends to seek additional bidders who may be interested not only in demolition of the structure but in renovation of the structure and wish to notify the public of their intention to receive bids thereupon,

NOW THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF FRIEND, NEBRASKA as follows:


1. The City of Friend intends to sell the real estate located at 118 Main Street in Friend, Nebraska, which is legally described as Lot 160 of the Original Town. The City will accept sealed bids on the real estate through May 3, 2005. The successful bidder shall submit a plan for either the demolishing and removal of the building within ninety days from the sale of the real estate, or in the alternative, a plan for the renovation of the building to be completed within nine months after the sale of the real estate. The City Council reserves the right to reject any and all bids. The Clerk is authorized to publish and post notice of the intent of the City of Friend to sell the above real estate.
