WHEREAS, it is in the best interest of the City of Friend and Warren Memorial Hospital, under these circumstances, that Resolution 97-8 be repealed, now,

THEREFORE, be it resolved by the Mayor and City Council of the City of Friend, that Resolution 97-8 should be and hereby is repealed in its entirety.

That either the Mayor or the City Treasurer of the City of Friend, Nebraska is hereby authorized to execute and sign from time to time, on behalf of the City of Friend, promissory notes payable to the First National Bank, Friend, Nebraska for the purpose of obtaining operating capital for the day to day operations of Warren Memorial Hospital, Friend, Nebraska. The aggregate amount of total funds borrowed from time to time shall not exceed the sum of \$50,000.00 at any one time. Unless an emergency exists which effects the day to day operations fo Warren Memorial Hospital the City Council at its regular meeting or a special meeting, shall approve the indebtedness prior to its incurrence. Councilperson Tuttle moved the adoption of said Resolution. Councilperson Gill seconded the motion. Upon vote the following Councilpersons voted AYE: Smith, Tuttle, Gill. Himmelberg abstained.
