RESOLUTION 02-09

WHEREAS, Street Improvement District Nos. 2001-2 and 2002-1 and Street Improvement Project Nos. 2001-1, 2001-2 and 2001-3 of the City of Friend, Nebraska were duly created and the contract was let for the construction of certain improvements in each of such Districts; and

WHEREAS, said improvements have been completed and are hereby accepted by the Mayor and City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF FRIEND, NEBRASKA:

Section 1. The Mayor and City Council find and determine that the cost of constructing said improvements in Street Improvement District Nos. 20001-2 and 2002-1 and Street Improvement Project Nos. 2001-1, 2001-2 and 2001-3, including (a) the cost of improvements of intersections and areas formed by the crossing of streets, avenues and alleys, and (b) the cost of the improvements opposite abutting property (being all said improvements exclusive of intersections and areas formed by the crossing of streets, avenues and alleys), is as follows:

Section 2. The Mayor and City Council shall hold a special meeting at the City Hall in Friend, Nebraska on the 1st day of October, 2002 at 6:45 p.m. for the purpose of sitting as a Board of Equalization and Assessment to equalize and levy special assessments on the lots and parcels of land abutting on or adjacent to the streets, avenues and alleys improved in said Street Improvement Districts and Projects. Notice of the time of holding such meeting and the purpose for which it is held shall be published in the Friend Sentinel, a legal newspaper of general circulation in said City, for at least three (3) weeks (three(3) publications) before the date of the said hearing. The City Clerk is directed to cause said notice to be published as provided by statute. The City Clerk is also directed to mail a copy of said notice to all interested parties as required by law.

<u>Section 3</u>. The special engineer is directed to prepare and file with the City Clerk a map of the property in each of said Districts and Projects which shall be open for public inspection, upon request, at the office of the City Clerk.
