**RESOLUTION AND AGREEMENT
BETWEEN
THE CITY OF FRIEND, NEBRASKA
AND
SALINE COUNTY, NEBRASKA
IN-FRIEND**

0.13 ± MILES 5TH STREET AND 0.30 ± MILES PAGE STREET

WHEREAS: Certain roads and streets in Saline County have been designated as being eligible for Federal Funds by the Federal Highway Administration in compliance with Federal Laws pertaining thereto, and,

WHEREAS: The City of Friend, Nebraska and Saline County, Nebraska desires to improve a certain portion of the City Street System and the County Road System more fully described hereinafter, now thereto,

BE IT RESOLVED: That Saline County is hereby requested to act for the City of Friend, Nebraska and to program for construction that portion of a road as described:

Beginning 0.7 ± miles north and 0.13 ± miles west of the S.W. corner of Sec. 24-T8N-R1E; thence east 0.13 ± miles, located on 5th Street, City of Friend, Nebraska.

Beginning 0.7 ± miles north of the S.W. corner of Sec. 24-T8N-R1E; thence north 0.30 ± miles, located on Page Street, City of Friend, Nebraska.

Grading, Culverts, Storm Sewer, Surfacing, Right-of-Way Acquisition, and Utility Relocation.

BE IT FURTHER RESOLVED: That the Mayor of the City of Friend is authorized to sign this agreement on behalf of the City of Friend and that the City Council of Friend hereby approves the contemplated construction prior to first submitting of said project to the Federal Highway Administration.

BE IT FURTHER RESOLVED: That the Chairman of the County Board of Commissioners is authorized to sign this agreement on behalf of the County of

Saline and that the County Board of Commissioners hereby approves the contemplated construction prior to first submitting of said project to the Federal Highway Administration.

BE IT FURTHER RESOLVED: That sufficient funds of the City of Friend are now, or will be available and are hereby pledged to Saline County in the amount and at the required time for the purpose of matching Federal Funds available for the contemplated construction. (At the existing funding rate, twenty percent of the project costs for all construction work, engineering and utilities is the required City and County matching share of the funding.) The City of Friend will be responsible for paying 100% of the 20% Matching Funding for 5th Street and that portion of Page Street which is located in the City Limits (Estimated at 69% ± of Page Street costs.) The City of Friend will also be responsible for paying 100% of the cost of R.O.W. for all R.O.W. located within the City Limits. (R.O.W. costs are not eligible for funding participation.)

Saline County will be responsible for paying 100% of the 20% Matching Funding for Page Street which lies outside of the City Limits of Friend. (Estimated at 31% of Page Street costs.) Saline County will also be responsible for paying 100% of the cost of R.O.W. for all R.O.W. located outside of the City Limits of Friend. (R.O.W. costs are not eligible for funding participation.)

The estimate of costs for 5th Street is \$125,000.00.

The estimate of costs for Page Street is \$129,000.00

BE IT FURTHER RESOLVED: That the City of Friend will be responsible for acquiring all required Right-of-Way or Temporary Right-of-Way Easements needed to construct the project, and located within the City, if any is needed.

BE IT FURTHER RESOLVED: That Saline County will be responsible for acquiring all required Right-of-Way or Temporary Right-of-Way Easements needed to construct the project and located within the County and beyond the City Limits of the City of Friend, if any is needed

BE IT FURTHER RESOLVED: That the city of Friend and Saline County, Nebraska have been made aware that they will be required to fund 100% of Preliminary Engineering and Utility Relocation initially. 80% of Preliminary Engineering will be credited against project costs at the time of construction.

That the City of Friend and Saline County, Nebraska have been made aware that they will be required to fund 100% of R.O.W. Acquisition costs. (R.O.W. costs are not eligible for finding participation.

BE IT FURTHER RESOLVED: That Saline County is hereby requested to act for the City of Friend for all agreements required with the Nebraska Department of Roads.
