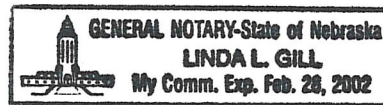

RESOLUTION NO. 99-9

WHEREAS, Nebraska Revised Statute 77-1601.02 provides that the property tax request for the prior year shall be the property tax request for the current year for purposes of the levy set by the County Board of Equalization unless the Governing Body of the City passes by a majority vote a resolution setting the tax request at a different amount; and

WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request; and

WHEREAS, it is in the best interests of the City of Friend that the property tax request for the current year be a different amount than the property tax request for the prior year.

NOW, THEREFORE, the Governing Body of the City of Friend, Nebraska, by a majority vote, resolves that:

1. The 1999-00 property tax request be set at \$145,800, of which \$13,000 is not subject to Levy Limits.

2. A copy of this resolution be certified and forwarded to the County Clerk prior to October 14, 1999.
