A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF FRIEND, SALINE COUNTY, NEBRASKA, APPROVING THE APPLICATION OF THE FARMERS UNION COOP COMPANY OF FRIEND, FOR A SPECIAL DESIGNATED PERMIT UNDER THE NEBRASKA LIQUOR CONTROL ACT, TO DISPENSE BEER AT THE BUSINESS APPRECIATION SUPPER TO BE HELD ON SEPTEMBER 6, 1997, IN THE CITY PARK OF FRIEND, NEBRASKA, THE SAID SPECIAL DESIGNATED BEER PERMIT TO BE LIMITED TO THE FENCED OFF AREA INSIDE THE TENNIS COURTS IN THE CITY PARK BETWEEN MAPLE STREET AND CHESTNUT STREET, BETWEEN THE HOURS OF 5:00 O'CLOCK P.M. ON SATURDAY, SEPTEMBER 6, 1997, TO 12:00 O'CLOCK MIDNIGHT ON SEPTEMBER 6, 1997, PURSUANT TO THE MUNICIPAL CODE OF THE CITY OF FRIEND, AND THE NEBRASKA LIQUOR CONTROL ACT.

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF FRIEND, SALINE COUNTY, NEBRASKA, that they hereby approve the application of the Farmers Union Coop Company of Friend, for a special designated beer permit for the fenced off area inside the tennis courts in the City Park between Maple Street and Chestnut Street, between the hours of 5:00 o'clock P.M. on September 6, 1997 to 12:00 o'clock midnight on September 6, 1997, pursuant to the municipal code of the City of Friend, and the Nebraska Liquor Control act.
