A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF FRIEND, SALINE COUNTY, NEBRASKA, APPROVING THE APPLICATION OF THE FRIEND VOLUNTEER FIRE DEPARTMENT, FOR TWO SPECIAL DESIGNATED PERMITS UNDER THE NEBRASKA LIQUOR CONTROL ACT, TO SELL LIQUOR, BEER AND WINE AT TWO SEPARATE FIREMAN'S CELEBRATIONS (1) APRIL 1, 1995 TO APRIL 2, 1995, AND (2) MAY 27, 1995 to MAY 28, 1995, IN THE CITY OF FRIEND, THE SAID SPECIAL DESIGNATED LIQUOR, BEER AND WINE SALE PERMIT TO BE LIMITED TO THE INSIDE AREA OF THE FIRE HALL AND THE FENCED OFF AREA, 100 FEET BY 100 FEET, FOR THE FIREMAN'S CELEBRATION TO BE HELD ON APRIL 1, 1995 TO APRIL 2, 1995 BETWEEN THE HOURS OF 12:00 NOON ON SATURDAY, APRIL 1, 1995 TO 1:00 O'CLOCK A.M. ON APRIL 2, 1995 AND A SPECIAL DESIGNATED LIQUOR, BEER AND WINE SALE PERMIT TO BE LIMITED TO THE INSIDE AREA OF THE FIRE HALL AND THE FENCED OFF AREA, 100 FEET BY 100 FEET, ON LOTS 221 AND 222 IN THE ORIGINAL TOWN OF FRIEND, SALINE COUNTY, NEBRASKA, FOR THE FIREMAN'S CELEBRATION TO BE HELD ON MAY 27, 1995 TO MAY 28, 1995 BETWEEN THE HOURS OF 12:00 NOON ON SATURDAY, MAY 27, 1995 TO 1:00 O'CLOCK A.M. ON MAY 28, 1995, PURSUANT TO THE MUNICIPAL CODE OF THE CITY OF FRIEND, AND THE NEBRASKA LIQUOR CONTROL ACT.
