

RESOLUTION 91-6.

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF FRIEND, SALINE COUNTY, NEBRASKA, APPROVING THE APPLICATION OF THE FRIEND VOLUNTEER FIRE DEPARTMENT, FOR A SPECIAL DESIGNATED PERMIT UNDER THE NEBRASKA LIQUOR CONTROL ACT, TO SELL BEER AND WINE AT THE FIREMAN'S CENTENNIAL CELEBRATION TO BE HELD ON JUNE 21 and 22, 1991 IN THE CITY OF FRIEND, THE SAID SPECIAL DESIGNATED BEER AND WINE SALE PERMIT TO BE LIMITED TO THE FENCED OFF AREA WHICH INCLUDES THE EAST TWO HUNDRED (200) FEET OF SECOND STREET BETWEEN MAIN STREET AND PINE STREET, BETWEEN THE HOURS OF 7:30 O'CLOCK P.M. ON FRIDAY, JUNE 21ST, TO 1:00 O'CLOCK A.M. ON JUNE 22, 1991 AND BETWEEN THE HOURS OF 7:30 O'CLOCK P.M. ON JUNE 22ND, TO 1:00 O'CLOCK A.M. ON JUNE 23, 1991, PURSUANT TO THE MUNICIPAL CODE OF THE CITY OF FRIEND, AND THE NEBRASKA LIQUOR CONTROL ACT.

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF FRIEND, SALINE COUNTY, NEBRASKA, THAT THEY HEREBY APPROVE THE APPLICATION OF THE FRIEND VOLUNTEER FIRE DEPARTMENT, FOR A SPECIAL DESIGNATED BEER AND WINE SALE PERMIT FOR THE FENCED OFF AREA WHICH INCLUDES THE EAST TWO HUNDRED (200) FEET OF SECOND STREET BETWEEN MAIN STREET AND PINE STREET, FOR THE FIREMAN'S CENTENNIAL CELEBRATION, TO BE HELD ON JUNE 21 and 22, 1991, BETWEEN THE HOURS OF 7:30 O'CLOCK P.M. ON FRIDAY, JUNE 21ST, TO 1:00 O'CLOCK A.M. ON JUNE 22, 1991 AND BETWEEN THE HOURS OF 7:30 O'CLOCK P.M. ON JUNE 22ND, TO 1:00 O'CLOCK A.M. ON JUNE 23, 1991, PURSUANT TO THE MUNICIPAL CODE OF THE CITY OF FRIEND, AND THE NEBRASKA LIQUOR CONTROL ACT.
