A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF FRIEND, SALINE COUNTY, NEBRASKA, APPROVING THE APPLICATION OF DUANE E. AND RUBY M. HULSE, LIQUOR LICENSEES DOING BUSINESS AS "THE PUB", FOR A SPECIAL DESIGNATED PERMIT UNDER THE NEBRASKA LIQUOR CONTROL ACT, TO SELL BEER AT THE JULY 4, 1987 INDEPENDENCE DAY CELEBRATION AT THE CITY PARK IN THE CITY OF FRIEND, THE SAID SPECIAL DESIGNATED BEER SALE PERMIT TO BE LIMITED TO THE FENCED OFF AREA OF THE TENNIS COURT SEPARATED FROM THE DANCE AREA BETWEEN THE HOURS OF 7:00 O'CLOCK P.M. 


