WHEREAS, this is a Resolution of the Mayor and City Council of the City of Friend, Saline County, Nebraska authored and passed on May 6, 1986 at regular council meeting.

WHEREAS, a Resolution of the Mayor and City Council of the City of Friend, Saline County, Nebraska declaring an emergency and setting forth the necessity for entering into a contract with Universal Engineering Company of Geneva, Nebraska for the blacktop overlayment of previously paved streets in the City of Friend, to-wit: Second Street from the intersection of Second and Pine Street to the intersection of Second and State Street and Third Street from the intersection of Third and Chestnut Street to the alley East of Third and Chestnut Street for the reason that said concrete has cracked and worn considerably but can be repaired by the use of asphalt overlayment; that the said Mayor and City Council of the City of Friend informally received bids for said hauling and laying of said overlayment and in the alternative for hauling the overlayment and the City performing the laying of the overlayment and finds that the bid of Universal Engineering Company of Geneva, Nebraska is the lowest qualified bidder in the amount of \$15,259.35; that an emergency exists for the reason that said pavement is a hazard to the traveling public and is in danger of deteriorating even further than it already has and for the reason that Universal Engineering Company has a highway project in the Tobias area for which they already have an asphalt hot mix plant set up and can perform the work immediately.

IT IS THEREFORE RESOLVED by the Mayor and City Council of the City of Friend that the informal bid of Universal Engineering Company of Geneva, Nebraska in the amount of \$15,259.35 is accepted for hot mix asphalt overlayment on previously paved portions of Second Street from the intersection of Second and Pine Street to the intersection of Second and State Street and on Third Street from the intersection of Third and Chestnut Street to the alley East of Third and Chestnut Street.
