A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF FRIEND,  
WITH REGARD TO THE SPECIAL ELECTION TO BE HELD ON JANUARY 20, 1981.

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL AS FOLLOWS:

1. It has been determined by the Mayor and City Council of the City of Friend that there is no legal necessity for voting in wards at the special election to be held on January 20, 1981 for the reason that the issue is one to be decided upon a vote of the total eligible voters of the City of Friend and that therefore, all voting at the special election in the City of Friend to be held on January 20, 1981 shall be held at the City Hall, which is designated as the official polling place. The Saline County Clerk who is handling the election shall be authorized to only appoint two judges and a clerk to the receiving board and two counting judges and to maintain and have open for voting between the hours of 8:00 o'clock a.m. and 8:00 o'clock p.m. on January 20, 1981 only one polling place, to-wit: at the City Hall in the City of Friend, Saline County, Nebraska.
