The realty and territory owned by the Friend Recreation Association, Incorporated, should be disconnected by Decree of the District Court of Saline County, Nebraska, upon the filing of a Petition by the owner, Friend Recreation Association, who is the sole and only owner of the territory embraced within the following legal description, to-wit:

A part of the Southeast Quarter of Section 23, Township 8 North, Range 1 East of the Sixth Principal Meridian in Saline County, Nebraska, more particularly described as follows: Commencing at the Northwest corner of the Southeast Quarter of said Section 23, thence proceeding a distance of 330 feet due East along the North line of said Southeast Quarter, thence proceeding a distance of 360 feet due South, thence proceeding a distance of 330 feet due West of the West line of the Southeast Quarter of said Section 23, thence proceeding a distance of 360 feet North along said West line to the place of beginning.
3. This Resolution is intended to be a voluntary appearance for all intents and purposes and to legally demonstrate to all persons whomsoever the general appearance of the City of Friend to the Petition of the Friend Recreation Association, a Corporation, for disconnection.
